## Beacon Sloop Club General Meeting Minutes, October 1, 2010

**Call to Order, Rosemary Thomas.** Rosemary welcomed new visitors from Beacon, Maui, England, and New York City.

**Treasurer, Sarah Elisabeth.** Besides income and expenses for the Corn Festival, Sarah reported a new grant from the Coyote Foundation for \$5000. The Woody raffle brought in over \$1000. Our closing balance was \$62,662.86. The current Treasurer's report is elsewhere in the Broadside.

**Woody Guthrie, Jim Birmingham.** Mary Schmalz thanked all the sailors and volunteers who helped make the Ramble a big success this year. Evening sails continue till late October after the Pumpkin Festival. Volunteer sailors are welcome for the event.

**Building Committee, Claudine Craig.** Gigi Fris and Alice Vaughan with help from other volunteers including Liz Nedwell and Mark McCarroll have finished cleaning and painting the interior of the Club. The wood rack is under construction. Work on the patio will proceed pending the blessing of the DEC. Saul Rozinsky and Ron Bell repaired the rot and trim and the multrum has been pumped out. Saul & company are looking into repair of the fireplace. Mark McCarroll reported meeting with the Dutchess County soil & water conservation district. They are willing to help with grants for repair of the sea wall behind the patio. Dan Searles suggested that members bring rocks of 8-12" thickness of virtually any size to the rear of the Club over the next few months. Caitlin O'Heaney, Multrum Queen, needs a volunteer to unclog the urinal. Someone broke into the Multrum supply cabinet and it will be repaired soon.

**Pumpkin Festival (October 17), David Eberle.** A repair kit has been ordered for the Strawberry Tent. It was put away wet and some rodent and water damage caused holes. David called for volunteer pie makers to help with making crust & filling and baking pies at the Dutchess Junction Fire Hall on Rt. 9D south of Beacon on Saturday, October 16. Again, volunteers are wanted for garbage and recycling. Betty Harkins will help with recycling of plastic containers.

**On-line Donations.** The on-line membership and donation system is very close to completion.

**Elections.** We will have election of officers at the December meeting. Rosemary called for volunteers for a nominating committee and for nominations from the floor. Tom LaBarr nominated Steve Schwartz for President. David Eberle nominated Rosemary Thomas. Claudine Craig was nominated for Vice President, Sarah Elisabeth for Treasurer and Vane Lashua for Secretary.

**Executive Meeting.** Rosemary listed items approved at the Executive Committee meeting on September 26: The Executive Committee accepted the Treasurer's report; approved extending our current insurance policy for another year; approved proposing formalization of a long-term agreement and understanding with the City of Beacon; approved spending \$300 for BSC reps to attend the Southern Dutchess NAACP event where the club, along with three other environmental organizations, is being honored; approved joining the Beacon Chamber of Commerce. Non-profit membership is free(!).

## GE proposal spurs new debate on PCB Contamination in the Hudson River

General Electric proposed to the EPA recently that it be allowed to extend the test phase of Hudson River dredging through next year to collect more data, instead of starting the far larger, second phase of the Superfund cleanup.

In a letter to EPA Administrator Lisa Jackson, GE argued that the review panel's findings show that it makes more sense to complete the unfinished Phase 1 next year. GE vice president Ann Klee said, "This approach would provide both EPA and GE with the basis to make informed decisions on Phase 2," An EPA spokeswoman said the agency was reviewing the letter.

The independent review panel report called for changes to procedures and standards for the project. They raised the possibility that the project may take seven dredging seasons to complete rather than the five previously planned.

If GE declines to complete dredging, the EPA could continue and seek to recoup triple costs from GE.

Dear Sloop Club Friends,

An updated and revised Indian Point Fact Sheet is now available. It is a fairly lengthy report but the headings should make it easy to locate the information you need without wading through the whole report. I made every effort to avoid technical jargon and to keep it readable. Let me know if I succeeded. It is posted on Ground Report for now. I do not know how long it will be available there, so if you are interested, I suggest that you download it soon.



I included the part on DEC recommendations and the description of different methods of closed cycle cooling in this email because Entergy, the owner of the plant, has done an excellent job of confusing this issue. They use the term cooling towers and closed cycle cooling interchangeably for their own nefarious purpose. They are not interchangeable. Closed cycle cooling includes several different technologies. Cooling towers are by far the most expensive and intrusive and therefore the easiest to make a case against. The company is pushing for wedge wire which does not reduce water usage or thermal pollution and was never designed for the volume of water a power plant uses.

I have to say that the DEC has been missing in action in informing the public of what is going on. I know several reporters who have given up trying to get information through the PR people at DEC. It has been next to impossible to get to people in the department for help and explanations. If anyone knows Pete Granis I hope you will share this information with him.

### New York State Department of Environmental Conservation Recommendations

In the policy document *Best Technology Available for Cooling Water Intake Structures*, dated March 4, 2010, the New York State Department of Environmental Conservation establishes cooling towers or "or dry closed cycle cooling" as the best technology available for **new** construction. For retro fitting **existing** plants "wet closed cycle cooling" or mechanical draft is recommended.

Here's the difference: dry closed cycle cooling uses air to cool the water which is why towers are essential to the design. It eliminates water use by 97% and fish kill by 95% which is why it is gold standard for new construction. Wet closed cycle cooling uses some water but only 2 to 7% as much as the current once through system. Fish kill is just as markedly reduced. Therefore, it still meets the criteria for best technology available. The wet closed cycle cooling or mechanical draft system operates much like a car radiator. It is standard in the industry, much cheaper than cooling towers and less obtrusive. The system is housed in large industrial type buildings. Vermont Yankee, another somewhat smaller plant which Entergy owns, has had this system in place for years

### Hydrofracturing Alert!

The Delaware River Basin Commission (DRBC) is about to issue a broad range of regulations related to how gas drilling using hydrofracking will be conducted in the Delaware River Basin. These regulations are being issued in spite of calls from federal officials, federal agencies and environmental groups that the Commission wait for the results of the EPA Hydraulic Fracturing Study, which is now being conducted and a Cumulative Impact Study proposed by Rep. Maurice Hinchey whose funding is currently being approved by Congress.

Brig. Gen. Peter "Duke" Deluca, the Army Corps of Engineers federal representative on the Delaware River Basin Commission has said that the Commission will not wait for the results of these scientific studies because it does not want to delay the economic boost he says that drilling could bring.

In a strongly worded response, Rep. Hinchey reminded the General that the DRBC's mission is the environment and not the economy and that under the DRBC Compact and other federal designations impacting the Delaware River Basin, such an interpretation of the federal role is inappropriate and has no basis in statute or regulation.
